- 1. With international students

## **Strategic Aim 1:**

Provide prospective, current and returning international students with the supports they want and need

## **Objectives**

- 1.1 Include the international student voice in all of our work
- **1.2** Publicise ICOS to international students initially and keep them informed throughout their studies in Ireland
- **1.3** Provide international students with the information, advice and advocacy they need to have a positive experience in Ireland
- **1.4** Provide international students with training that enables them to optimise their experience of studying in Ireland
- **1.5** Provide international students with opportunities to get to know and communicate with each other
- **1.6** Undertake research about and with international students and act on the findings
- **1.7** Understand the needs of international students with additional support needs to ensure equity and inclusivity
- **1.8** Deliver a growing and professional Ireland Fellows Programme that operates in harmony with the rest of our work
- **1.9** Work with and collaborate with international students and student groups on common goals

- International students feel supported
- International students are able to exercise their rights
- International students experience less difficulties in their international education journey
- International students have an understanding of the culture in which they are living
- International students feel part of the community





Provide ICOS members, schools and institutions with the supports they need in order to offer the best possible international student experience

#### **Objectives**

- **2.1** Engage proactively with multiple stakeholders within member organisations
- **2.2** Run training events, both off-the-shelf and bespoke, for staff working in any schools and institutions that have international students, with a particular focus on intercultural awareness and inclusion
- 2.3 Facilitate inter-institution working groups to progress issues of relevance
- **2.4** Encourage greater involvement of higher education institutions in the Ireland Fellows Programme
- 2.5 Organise an annual conference on best practice in international education

## **Strategic Aim 3:**

#### **Objectives**

- **3.2** Nurture and make use of positive relationships with key media contacts
- **3.3** Enable greater intercultural sharing between international and domestic students
- **3.4** Explore the viability of an international student award scheme/ceremony
- **3.5** Facilitate volunteering by international students
- **3.6** Open up employment pathways for international students (during and post-study)

- Public policy that is supportive of international education, its students and their rights
- Day-to-day practice that makes things simpler and better for international students
- More and improved media coverage about international students
- Greater public awareness of the multiple benefits of international education
- Reduced racism and other forms of prejudice towards international students

Make active connections between the international education experience in Ireland and the rest of the world

#### **Objectives**

- **4.1** Firmly position our work within the Sustainable Development Goals framework
- **4.2** Foster continued connection between alumni of the Ireland Fellows Programme and Ireland
- **4.3** Keep informed of best practice in international education around the world
- **4.4** Share our own experience and knowledge of international education beyond Ireland

- A minor but meaningful contribution made towards global development
- Enhanced reputation for Ireland in the area of intercultural competence
